- The sessions of parliament in November are characterized by a big number of legislative acts and some of supervisory activity : the first reading of bill of labor, bill of third amendment of ministry of water resources law No. 5, statistic bill, bill of second amendment of investment law No. 31/2006, bill of communications. The council completed the back read of

ministry of health bill, outvoted, in principle, on the bill of organizing Turkman rights after its first reading and also voted on the bill of communications and informatics, in order to continue it. It also postponed voting on a resolution to consider ISIS terrorist groups' crime against Iraqi people as genocide and crimes against humanity, they postponed it for the purpose of producing a mature one. Other bills were, investment between Iraq and Jordan, a bill to ratify an agreement between Iraq and Kuwait of encouragement and protection of mutual investment.

- For the supervisory level, the council hosted prime minister Mr. Haider Al Ibadee to review the current situation of Iraq and also hosted minister of oil Adeel Abed Almahde to review the situation of economy and oil and details of the agreement between the federal government and Kurdistan province.

- With regard to following up committees which were formed by the council and are responsible for governmental grant of displaced people read, a report about its tasks. The council voted on a report of the parliament committees of Alsejer and Alsaqlawea incidents at a secret session, it voted on a resolution to set up an investigative committee upon a request from 98 MPs to investigate the reasons behind Nenawa governorate overthrow and people who involved in it. Committee of security and defense and committee of human rights read, the elementary report about Spyker base crime, which included many governorates.

- The Iraqi parliament held ,on 1-11-2014 the session (26) of the first legislative term /first legislative year . Headed by the speaker of the parliament Salim Aljboure, in the presence of (215) MPs. The session is included :

Salim Aljboure has confirmed, that the sevenfold committee is established to facilitate choosing committees members. The parliamentary blocs can benefit from its recommendations to choose chair, deputy chair, rapporteurs. This committee has no power to release decisions .

- MP. Ala Talabane has read, a statement in the anniversary of Imam Hussein martyrdom. She pointed out in her statement that all humanity is participating in retrospect Imam Hussein martyrdom , which commits us to impart the noble meanings and to be stable on principles and justice .

- MP. Abed Alrahman Al-loueze has read, a statement about the security and humane situations in Nenawa governorate. He pointed out in his statement to the increasing crisis there, power off and campaigns of Daesh, the terrorist group, to arrest army officers, politicians, activists and mass execution. Calling for holding an extraordinary session at the parliament, to discuss the humane situation in the governorate. He also called the cabinet to do its tasks completely to alleviate people suffering.

- MP. Joseph Slewa has read a statement, in the fourth ceremony of Saedt Alnajat Church massacre. He condemned in his statement, the crime of terrorist where they made an offence on the church while the innocent people were praying and also they forced Christians to leave Nenawa, for the first

time since two thousands years. Confirming on that Christians are insisting to stay in Iraq, in spite of what terrorist are doing.

– MP. Fares Alfares has read, a statement about the situations in Alanbar governorate, by the name of provincial council, he indicated the current emergency situations in Alanbar. Characterized by the terrorist group of Daesh.

- The first reading of the draft resolution of organizing Turkmen rights. Which is presented by the committee of human rights.

- The council outvoted ,in principle, on the draft resolution of organizing Turkmen rights. After the first reading of the draft resolution.

- Reading the notes and recommendations of the permanent parliamentary committee of displaced issues.

- The council voted on the recommendations. Which are included in the report of the permanent parliamentary committee of displaced issues, in order to be included in the parliament resolution.

- First reading of labor draft resolution. Which is presented by the committees of labor and social affairs and civil community foundations. 59 articles have been completely read from 157 articles.

- The Iraqi parliament held, on 11-11-2014 the session (27) of the first legislative term/ first year of the third term. Headed by the speaker of the parliament Salem Aljboure, in the presence of (229) MPs. It is included:

- Mr. Salem Aljbour declared, that MP. Angham Alshmousy was stricken with criminal incident by terrorist, who targeted her home this morning. And she is now being treated.
- MP. Zaid Abed Alkareem read, a statement, he condemned in his statement the assassination of Okab Aljanabe, the member of Babylon provincial council and Abraham Aljanabe, judge of Almseeb court. After a month since they have been kidnapped.
- The council voted on report of the parliamentary committee, about what took place in Alsejer and Alsaklawea. In a secret session.
- The first reading of third amendment bill, of ministry of water resources law No. (50)/ 2008. Which is presented by the committee of agriculture, waters and Marshes.
- Postponing first of second amendment bill, of investment law No. (13)/ 2006. Which is presented by the committees of economy, investment and finance. Upon the request of the competent committees.
- The first reading of statistics bill, which is presented by the committee of economy and investment.
- Continuing first reading of labor bill, which is presented by the committees of labor, social affairs, civil community and legal institutions. It's included 157 articles. The council has finished 59 readings out of all articles last session.
- MP. Bader Alfaheel read a statement, he recalled in his statement the martyrdom of Imam Hussein and his great doings to succor tyrannized people. He pointed out that Alalem township in Salah Aldeen governorate have thwarted to Daesh terrorist group by its loyal tribes.

- The Iraqi parliament held, on 13-11-2014 the session (28) of the first legislative term, first year, third term. Headed by the speaker of the Iraqi parliament Salem Aljboure, in the presence of (232) MPs. It is included:

- The council voted, on approval of MP. Iman Hamed membership validity. After an objection submitted by MP. Haider Sattar, about the parliamentary seat of the alternative deputy.

- MP. Ferhad Kader Kareem read, a statement and condemned the suicidal explosion. Which targeted innocent people in Koks township.

- The back read of a bill to ratify an agreement of economical, commercial, scientific and technical cooperation. Between Iraqi government and Armenia government, which is presented by the committees of foreign relationships and economy and investment.

- The back read of a bill of Republic of Iraq accession to international railway agreement in Levant and its two protocols. Which is presented by the committee of facilities and construction, and the committee of foreign relationships. The presidency decided, to refer the bill to the committee of foreign affairs ,in order to, study it and submit it in Saturday session to complete its discussion. After objections that were submitted about it.

- The back read of ministry of health bill, which is presented by the committee of health and environment and the legal committee.

- The Iraqi parliament held, on 15-11-2014 the session (29) of the first legislative term, first year, third term. Headed by the speaker of the Iraqi parliament Salem Aljboure, in the presence of (217) MPs. It is included:

- Mr. Salem Aljboure called, the committee of education and the committee of displaced to host Minister of education, in order to, discuss displaced students affairs.

- The parliament voted, on forming a parliamentary investigative committee, upon a request of 89 MPs. To investigate reasons of Nenawa governorate overthrow and the involved people in it. This committee will include representatives of the governorate and others from other blocs, the committee of security and defense will supervise on it.

- Mr. Salem Aljboure congratulated, electing of chairmanships of some of parliamentary committees. Calling to choose rest of chairmanships quickly.

- Re-back read of a bill of Republic of Iraq accession to International railway agreement in Levant and its two protocols. Which is presented by the committee of facilities and construction, and the committee of foreign affairs. Which was read last session, in order to amend the objections about it.

- The Iraqi parliament held, on 17-11-2014 the session (30) of the first legislative term, first year of the third term. Headed by the speaker of the parliament Salem Aljboure, in the presence of (237) MPs. It is included:

- Swearing of MP. Hadee Alamere, as a member in the council of deputies.

- The council hosted, minister of oil Adeel Abed Almahde. To review economical and oil status and the agreement between federal government and Kurdistan province.

- Postponing back read of, a bill of ratification an agreement between Iraqi government and Jordanian government to encourage and protect investment. Which is presented by the committee of foreign relationships and the committee of economy and investment.

- Postponing back read of, a bill of ratification an agreement between Iraqi government and Kuwait for mutual protection and encouragement of investment. Which is presented by the committee of foreign relationships and the committee of economy and investment.

The Iraqi parliament held, on 25-11-2014 the session (31) of the first legislative term, first year. Headed by Salem Aljboure, in the presence of (262) MPs. It is included:

-MP. Intesar Aljboure read, a statement in which she pointed out to a feminist delegation visit to Alnajef governorate, to condole people there on the occasion of household captivates women on day one of Sofar. It included meetings with the religious reference, who expressed that they object any assault

on human dignity and confirm on the right of women in society.

- MP. Zainb Aref Albasree , a member in committee of martyrs and political prisoners, read a statement in which she recalled the anniversary of Kabthat A lhuda issue and martyrs of Islamic movement, who were killed by the deposed regime. Indicating that martyrs of Islamic movement had presented a unique example of challenge, steadfastness and sacrifice against the most powerful dictatorship.

- MP. Meshah'n Aljboore read, a statement in which he praised, the act of 300 militant who kept Baiji oil refinery safe from the attacks of Daesh.

- The council voted on, electing the parliamentary committee of assessing the security situation in Deala governorate, it includes members of the parliament; Hassan Salim, Raed Aldahlke, Kamel Alzede, Salah Aljboore, Bourhan Kadhem, Nahed Aldyne, Kasem Ala'reje, Abed Alaziz Hassan and Furat Altememi.

- The first reading of a bill to ratify an agreement of scientific and economic cooperation, between Iraq and Bulgaria. Which is presented by the committee of foreign relationships and committee of economy and investment.

- The first reading of a bill of first amendment of mass graves protection No. 5/2006. Which is presented by the committee of martyrs and political prisoners and the committee of human rights.

- Postponing first reading of ministry of transportation bill, which is presented by the committee of construction and facilities and legal committee. Upon a request of some

members to withdraw the law, which was presented in order to set a law for ministry of transportation and arrange an administrative structure for the ministry, after separating ministry of transportation into two ministries, transportation and communication.

- The council completed, back read of a bill of ratification an agreement of protection and encouragement the investment between Iraq and Jordan. Which is presented by the committee of foreign relationships and the committee of economy and investment.

- Back read of a bill of ratification between Iraq and Kuwait, to encourage and protect mutual investment. Which is presented by the committee of foreign relationships and the committee of economy and investment.

- Speaker of the parliament Salem Aljboure confirmed, that the council will ask the government to send 2015 federal budget, for the purpose of discussion. Confirming that, it is illegal to hold a session after the end of legislative term, except in the case of receiving the budget from the government.

- Speaker of the parliament called, the committee of security and defense to follow up situations and take the necessary measures in Baled and Aldejel. Which are coming under mortar shells attacks by terrorists.

The Iraqi parliament held, on 27-11-2014 the session 32 of the first legislative term, first year. Headed by Salem Aljboure, in the presence of 232 MPs. It is included:

- Salem Aljboure declared, that the presidency have discussed with blocks chairmen and the committees some regulatory issues and council performance in the next phase. They have agreed upon forming a committee from the parliamentary blocks, to follow up the governmental programme, the political agreement paper and they confirmed on necessity of choosing chairmanship of the committees quickly. Pointed out that 30-11 is the end of the legislative term and the start of the legislative vacation that lasts one month, except the case that the budget arrives .

- The Iraqi parliament held, on 29-11-2014 the session 33 of the first legislative term, first year of the third term. Headed by the speaker of parliament Salem Aljboure, in the presence of 242 MPs. It is included:

- Salem Aljboure affirmed that it was scheduled to host prime minister Haider Alebadee to submit 2015 federal budget at this session, but the cabinet considered to hold a session to resume discussion about the budget. Pointing that prime minister will attend the session of the parliament tomorrow to submit and read the budget.

- The speaker of the parliament called chairmen of the parliamentary blocks to take into account the representation of women in the parliamentary committees.

- The first reading of a bill to amend the law of legal provisions which prevent courts from listening to lawsuits No. 17/ 2005, that is presented by the legal committee.

- The first reading of a bill to amend the law of essential criminal procedure No. 23/ 1971, which is presented by the legal committee.

- The first reading of a bill to amend the law of judicial fees No. 114/ 1981, which is presented by the legal committee and financial committee.

- The first reading of a bill of communications and informatics, which is presented by the committees of facilities and construction, media and culture and legal committee.

- The council approved, in principle, to resume communication and informatics bill legislation.

- Salem Aljboure called, the parliamentary blocks to submit, the names of the special parliamentary committee members, this committee will monitor governmental programme and political agreement paper.

- **The Iraqi parliament held, on 30-11-2014 the session 34 of the first legislative term, first year of the third term. Headed by the speaker of the parliament Salem Aljboure, in the presence of 236 MPs. It is included:**

- The committee that is responsible for displaced people grant read, a report about its tasks and that it will hold meetings with the competent authorities in Kurdistan province to distribute 225 million and 855 thousands IDs. From the council on displaced people in Irbeel and Dohouk and to alleviate suffering of special needs 'disabled' Yazedi women.

- The council voted, on a bill to ratify an agreement of encouragement and protection of investment between Iraq

and Jordan. Which is presented by the committee of foreign relationships and committee of economy and investment, this law is to ratify the agreement that was signed on by the two countries on 25-12-2013.

- The council voted, on a bill to ratify an agreement between Iraqi government and Kuwait government for mutual encouragement and protection, which is presented by the committee of foreign relationships and the committee of economy and investment.

- The council voted, on a bill to ratify an agreement of economic, commercial, scientific and technical cooperation between Iraq and Armenia, which is presented by the committee of foreign relationships and the committee of economy and investment.

- The parliament hosted, prime minister Haider Alibade to review Iraqi general situation.
